Terms & Conditions of the 2017 Maker Market event

1. Your application must be received by the CS Creative Arts & Crafts Committee by the deadline posted above. Late or incomplete applications will not be considered.
2. If you need help filling out the online application, please email cs.makermarket@gmail.com and our Vendor Liaison will be happy to help.

SELECTION PROCESS

3. Artists will apply to participate and all applications will be evaluated by the jury for product originality, marketability, quality, uniqueness.
4. The jury selects the artists that will be considered for inclusion in the Market. The CS Creative Arts & Crafts Committee reserves the right to approve the final selections based on the Maker Market criteria and to present a market that balances subjects, styles, mediums, and overall product mix.
5. The decision of the CS Creative Arts & Crafts Committee is final and at their sole discretion.
6. The Artist will be notified via email by the date listed above if they are selected. The email will include a Vendor Acceptance package with all information about showing at the Maker Market.



PAYMENTS

7. The 50% deposit payment due from the Artist must be **received** by the deadline noted above, either by online payment or by cheque made payable to the Calgary Stampede at the address noted in the Vendor Acceptance package.
8. Failure to make the 50% deposit payment by the deadline noted above may result in the CS Creative Arts & Crafts Committee cancelling your application, at our sole discretion.
9. The final 50% deposit payment must be **received** by the deadline noted above, either by online payment or by cheque made payable to the Calgary Stampede at the address noted in the Vendor Acceptance package.
10. Failure to make the final 50% deposit payment by the deadline noted above may result in the CS Creative Arts & Crafts Committee cancelling your application, at our sole discretion.
11. The 50% deposit is non-refundable. The booth rental fees are non-refundable. Serious and recent extenuating circumstances may be considered for refund by the CS Creative Arts & Crafts Committee, at our sole discretion.
12. Accepted artists not paid in full will not be considered for future Maker Markets.
13. The Artist is responsible for all financial processes related to the sale of its goods: payment, inventory management, receipts, collection of GST (if necessary), and cash float.

EVENT RULES

14. The Artist is responsible for their own insurance. The CS Creative Arts & Crafts Committee is NOT responsible for loss or damage. Items can be left overnight as the BMO Centre buildings are locked with security.
15. The Artist agrees to be on time for set up and take down as described in the Vendor Acceptance package.
16. The Artist agrees to be on time and open for business during Maker Market operating hours each day, usually 11:00 am to 11:00pm. Operating hours for each day are described in the Application Information package.
17. The Artist's booth **must be staffed at all times**. No leaving early. Security personnel are not responsible for supervision of your booth if you aren't there.
18. The CS Creative Arts & Crafts Committee will be supervising set up, take down and operating hours. Artists who show up late, leave early or leave their booth unattended for more than ten minutes will not be considered for participation in future Maker Markets.
19. Signage will be provided for each Artist. You may distribute business cards and brochures.
20. The Artist agrees to keep the rented booth space tidy and attractive. Additional inventory or boxes must be stored under the skirted tables. Your studio must keep within the boundaries of your booth space to ensure free flow of traffic and to ensure everyone's safety.
21. Artists are not permitted to nail or pin anything to the walls of the booth.
22. Artists should be prepared to discuss their work and be friendly to the many guests.
23. Artists must use the skirting provided to maintain a uniform presentation.

UNDERTAKINGS AND WARRANTIES BY THE ARTIST

24. By applying to the Maker Market, the Artist agrees to abide by these terms and conditions.



25. The Artist warrants that they are a resident of Canada and that the products being submitted for application are made in Canada.
26. The Artist warrants that the products submitted are the original work of the Artist and that the Artist contributed to at least 75% of the end product. No third-party produced products are permitted.
27. The Artist warrants that the products to be sold at the Maker Market are as described in application. Any material substitutions must be approved in writing prior to the event by the CS Creative Arts & Crafts Committee. The CS Creative Arts & Crafts Committee reserves the right to withdraw any pieces, products or Artists that is inappropriate or inconsistent with their application.
28. The Artist warrants that it holds the copyright to the products. Items that copy, reproduce, imitate or otherwise infringe on someone else's copyrighted material without written permission to do so will not be considered.
29. The Artist grants permission to the Calgary Stampede to use the images provided by the Artist for marketing and promotion, without limitation.
